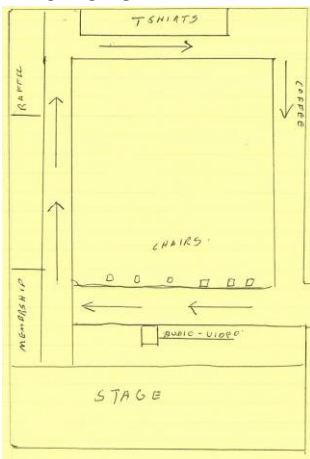
NEW SIGN IN PROCEDURE AT MEETINGS

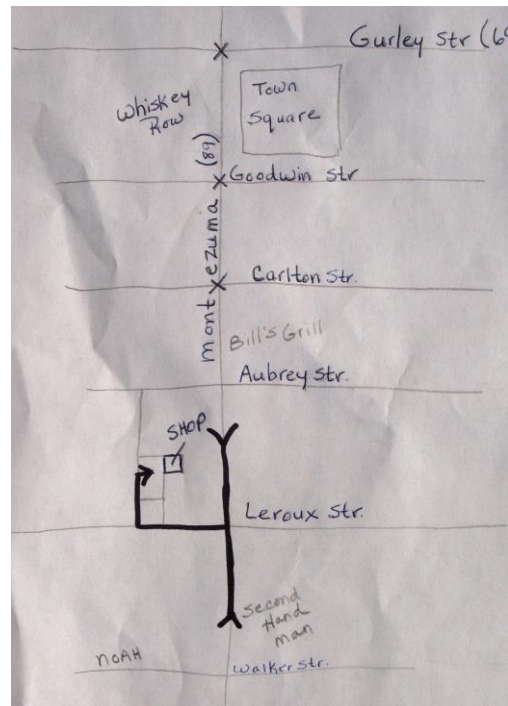

Carolyn Johnson gave the Treasurer's Report.

Nick Sacchetti gave the Programs update. Today's speaker is Les Presmyk. His presentation will be on Arizona quartz. April is our Silent Auction; May is Sindi Schloss on use of stones for adornment throughout history. We will be participating in Earth Day on the Square in Prescott at the end of April. We've been invited to have a club table there, which could include membership information. Nick asked Membership if we had a quorum. Debbie Ramsey verified that we had a quorum. Nick made a motion to have a club table, seconded by Ed Sullivan. Motion passed. The date is April 20.

There are sign-up sheets on the table. Lunch (hot dogs and hamburgers) will be provided by Dobel Ranch for those that sign up. You can bring your own lunch if you prefer. Cost is \$40 for 5 gal bucket or you can spread on ground and she'll give you a price. There are 2 areas there; one owned by brother and one owned by his sister. We will be going to the sister's area. The Secretary of the Coconino club has contacted me to see if we will be going to Baghdad area. Would like a 2-club field trip. We may possibly do this in the fall.

Federation will have one meeting at the Event Center. Other events will be held at the Prescott Resort. **We are not liable for anything**. Our members can attend the events at the Resort, which include a banquet. More info will be sent out when the date gets closer. Colleen discussed the display cases which the Federation will be judging. They must meet their specifications. Colleen will check on if our cases meet those specs.
